Rules and Regulations of the Great Neighbors' Duck Pond

The Great Neighbors' Duck Pond is a raffle fundraising event for Neighbors, Inc., a nonprofit agency under the 501(c)(3) status of the Internal Revenue Service. Tax ID # 41-1360294. The Great Neighbors' Duck Pond complies with all Minnesota Gambling Control Board requirements.

- 1. By entering the raffle, all winners agree that their names and likenesses can be used for promotional purposes by Neighbors, Inc. with no additional compensation. All decisions and interpretations of rules and regulations will be made by Neighbors, Inc. and their judgment is final. A copy of the rules and regulations will be made available to any person through written request, with a stamped and self-addressed envelope provided by the requestor, at Neighbors, Inc.'s address of record.
- 2. Adoptions, at \$5 apiece, can be purchased from members of the Great Neighbors' Duck Pond Event Staff. All bounced checks will be returned to the buyer and all fees will be charged to the buyer. Neighbors, Inc. will determine the minimum and maximum number of duck adoptions sold and entered into the pond. All entry sections must be filled out completely and clearly and delivered to an authorized Neighbors representative to be eligible to win any aforementioned prize. Must be 18 years of age or older to adopt ducks.
- 3. A number will be put on each duck that will relate to the adoption certificate. All ducks entered will be made available by Neighbors, Inc. and remain the property of Neighbors, Inc. Multiple duck adoptions may relate to one Duck Code certificate. Once the ducks are put in the water, they will not be touched or interfered with.
